TEAM OVERVIEW

Senior team is now 7 strong - 4 management + 3 RPs

Overall the team is in good shape.

Ratio of male educators is up and that is really good for both the team dynamic and the children.

FINANCIAL HEALTH:

Cash reserves approx \$70k

2023 ran at a loss of \$60k

- \$30k is a new entry for long service leave liability
- remainder we can attribute to wage increases in Jan only offset by session fee increases from July

FINANCIAL STATEMENTS FOR FY2023

Full year financials for January – December 2023 were audited by Elite Partners and financial statements provided. The auditors have made no qualifications to trading accounts.

Audit report was emailed to Exec, printed for meeting and stored on the Committee G-Drive

FINANCIAL SUMMARY

The Centre's full year revenue was \$918,438 in 2023, versus revenue in 2022 of \$850,050.

The full year expenses in 2023 were \$979,994, versus 2022 expenses of \$705,204.

Overall result was a deficit of \$61,556 for the 2023 financial/calendar year.

Extraordinary expenses for 2023 totalled \$92,140

- \$50,000 transferred to P&C accounts for funding of school projects
- \$42,140 donated to school for purchase of laptops

Total net deficit for 2023 was \$153,696

Retained surplus from previous years was \$385,204, leaving a closing retained surplus of \$231,508.

There is \$200,000 in CBA Term Deposits earning ~4%
